



STUD SERVICE AGREEMENT

*******All STUD credits expire after 2 years from time of lock in. Lock in fees can be transferred to a different stud even after credits expire. This credit is VALID only for the listed REGISTERED OWNER/S of the bitch above. If the bitch has not been selected yet, type N/A under the bitches name and fill out name of the person this credit is being purchased for under REGISTERED OWNER/S. This agreement is only valid with the listed owner/s purchasing this credit. The owner/s of this STUD credit must be listed on the bitches permanent registration, either as the sole owner or as a co-owner. All other third party transaction is prohibited and will invalidate this agreement.*******

STUD FEE

___ A total STUD fee of \$ _____ USD is to be paid in full before the breeding takes place. A \$500 USD non-refundable deposit is required to lock in the current fee as of the date of this signed agreement and secure breeding with said stud. All deposits and payments are nonrefundable. However, if the STUD is unavailable due to unforeseen circumstances, the deposit can be transferred to another available stud owned by the STUD owner.

SEMEN COLLECTION / SHIPPING CHARGES

___ The cost for semen collection, general semen analysis, packaging and handling, and priority next day shipping within the continental United States, is \$380 dollars. This fee does not included a full semen analysis by our veterinarian. A full analysis can be completed for an additional \$150 dollars. When available, fresh chilled semen can be shipped same day via various airlines cargo, and subject to carrier, location, and flight availability. An additional \$150 dollars on top of the \$350 collection and shipping fee will apply. 24 hours PRIOR notice is required to ship all semen.

___ The STUD owner is not responsible for delayed shipment due to carrier delays/negligence, or force majeure.

___ If fresh chilled semen is not available, frozen semen (if semen is already collected, stored, and available) can be shipped within the US at the bitch's owner expense prices subject to change. Collection and freezing cost will be waived by the STUD owner. Return of the shipping containers is the responsibility of the bitch's owner and must be returned within 24 hours using the attached prepaid return label. If not returned within 24 hours, bitch owner will be charged actual fees from the shipping veterinarian.

___ The bitch owner must report any issues with the semen quality prior to use or all guarantees will be voided. Semen used will constitute as a valid breeding attempt. If semen is to be discarded, proof from the veterinarian is required otherwise it will constitute as a valid breeding attempt.

___ International shipping fees will vary depending on collection method (frozen or chilled), type of shipment, location, testing, and paperwork required. There is an additional \$550 handling fee for all international shipments outside of Canada. ___ Frozen semen already processed and stored in other countries outside of the US, may be available for an additional \$1,500 on top of the listed stud fee. This is used to cover collection, freezing, taxes, handling, paperwork requirements, shipping, and storage expenses. All currently stored breeding units must be paid in full in order to secure each breeding unit. No lock ins will be accepted to reserve the unit.

BREEDING TERMS

___ The Stud Owner only guarantees healthy and viable semen (within established reproduction standards for fresh chilled or frozen semen for canine breeding, within the country where the semen is to be used).

___ Litter sizes may vary due to multiple factors outside of viable semen. Due to this fact, STUD owner is not obligated nor offer any guarantee to the size of the litter produced, as the result of this breeding.

___ As a courtesy, if less than 2 live and healthy puppies are produced (natural delivery voids this courtesy), a second breeding will be provided to the same bitch (at no additional charge for the STUD fee) within one year of this whelping. The bitch's owner will be responsible for any additional semen collection and shipping expenses.

___ A substitute bitch may be used but will be solely at the Stud Owners discretions and subject to a \$500 transfer fee.

___ Stud Owner has the right to request documented proof of all breeding's that resulted in less than two live and healthy puppies, failure to conceive, or any other instances where less than two live and healthy puppies were produced. Documents requested from the bitch's owner may include:

- Ultrasounds results completed on day 30-35 (dated along with the bitch's name) from a licensed veterinarian, indicating the number of puppy or puppies seen.
- A copy of an X-RAY completed at day 50-55 by a licensed veterinarian, showing the date completed along with the bitch's name and it's owners name, indicating the number of puppy or puppies born in this litter.
- All documents from the veterinarian must include details on the bitch(Name, Date of Birth, Owner, identifying colors or marks, etc), date service was completed, be written or typed on veterinarian company letterhead, and emailed to INFO@SSSBULLIES.COM. The bitch owner is REQUIRED to grant the STUD owner access to verify information directly from the bitch's attending veterinarian.

___ NO natural ties will be permitted.

___ Side by side breeding maybe allowed in person, at the agreed veterinarian office based on STUD owner and veterinarian availability. A negative brucellosis test must be completed on the bitch by a licensed veterinarian within 5 days of the breeding. The negative report must be sent to the STUD owner prior to the breeding taking place.

___ Any ISSUES with semen quality, upon receipt and proper testing by a licensed veterinarian, must be reported to the STUD owner prior to insemination. A full semen analysis by a licensed vet is required should a replacement be requested due to semen non-viability. A written statement or video proving that the semen was discarded and not used for the breeding is required for a replacement or repeat. Using the received semen to inseminate the bitch will constitute as a valid breeding attempt. Any deviation to this will void all guarantees on the semen.

PUP BACK AGREEMENTS

___ The BITCH owner is responsible for all whelping expenses related to the proper care of the puppies while in their care including necessary shorts and deworming.

___ All puppies are required to receive a general health check by a licensed veterinarian by 7 weeks of age, prior to picks being made. The full report must be made to the STUD owner prior to picks being made.

___ Picks are to be made by 8 weeks of the whelp date.

___ The pick puppy(s) must have a health certificate signed by a licensed veterinarian prior to transport.

___ While the STUD owner is responsible for the transport for the pick puppy, the BITCH owner must accommodate transport requirements such as meeting with the STUD owners shipping agent if necessary.

___ Bitch owner agrees to give up _____ over all puppy back as part of this agreement.

___ All litter registrations will be completed once the pick puppy is received in good health by the STUD owner.

LITTER REGISTRATION

___ Litter Registration Application(s) can be sent to the Stud Owner once the puppies have reached a minimum of 4 weeks of age, unless a pup back agreement is in place. All litter registration applications request must be emailed to INFO@SSSBULLIES.COM. Please include the name of the stud used and all owners/co owners name and emails. A Docusign form will be sent out for all parties to fill out and sign. Step by step instructions are provided on our website on how to complete this request.

BITCH OWNER AGREEMENTS

___ Progesterone testing is required and MUST be done by a licensed Veterinarian prior to all breeding's including repeated breeding's. Proof of said testing may be requested by Stud Owner at any time and MUST be provided by the bitch's owner.

___ Bitch's owner is required to immediately notify the STUD owner of all progesterone results (even if the female has not ovulated yet per test results) once received by the veterinarian. This is to ensure STUD availability on the date semen is needed for the scheduled breeding. Lack of notification will place your breeding at risk.

___ Bitch's owner is required to give the STUD owner a MINIMUM of 24 hours notice of when they need the STUD collected and shipped. STUD owner has the right to charge an EXPEDITED FEE of \$500 for any request not meeting this requirement.

___ The Bitch Owner guarantees that this bitch has not been bred to any other stud/s prior to being bred to the requested stud listed, and that she will be protected from such exposure after the breeding has taken place.

___ Dual sires are not permitted and will void any guarantees on repeat breedings. If any question of parentage should arise, the Stud Owner reserves the right to request DNA testing of the puppies at the Bitch Owner's expense.

___ The Bitch Owner agrees to promptly contact the Stud Owner after the puppies are born and inform them of the number of puppies produced in the litter.

___ The Bitch Owner understands and agrees that any guarantees given verbally or in writing to the puppy buyers from this breeding, are the sole responsibility of the Bitch Owner.

___ Stud Owner has permission to share information with any owners of the sire's offspring or close relatives, as well as post the information on their website/Social media outlets. Proper credits will be given.

___ Bitch's owner agrees to breed and use the received semen at their own risks and frees the STUD owner of any liability as the result of this breeding/s.

OTHER TERMS AND AGREEMENTS

___ **STUD credit not used within the first 2 years of the lock in date can be extended by paying the remaining stud fees in full along with the entire cost of freezing and storage of the STUD's semen. The following freezing cost is subject to change. \$750 for the initial cost plus \$150 every year after, prices subject to change.** This is to ensure the availability of the STUDs semen in the event of the STUD's expiration or any unforeseen breeding impairment(s).

___ The STUD credit may not be resold or transferred under any circumstances unless prior authorization from the stud owner is received.

___ When using frozen semen from an EXPIRED stud, bitch owner agrees that there will be no repeats given for the same stud. If a repeat is needed, an alternate STUD owned by the stud owner can be used in place of the expired stud. There will be no refunds once the frozen semen is used. If the frozen semen is determined to be non viable by a licensed veterinarian, documented proof from the licensed veterinarian will be required for a replacement.

___ When using STUDs who may carry genetic variants that may affect the over all health of their offsprings, the bitch owner agrees and accepts SOLE and all responsibilities with resulting puppies born from the breeding. The bitch owner agrees not to hold the STUD owner liable or responsible for the puppies born from the breeding.

___ When requested by the bitch owner, the STUD owner will provide all available genetic testing already completed for the STUD.

___ The terms of this agreement are to be kept completely confidential and is not to be shared with outside parties.
